WHAT HAPPENS AFTER I APPLY?

After you submit your application, a member from the NACO team will review the information provided to ensure you meet the eligibility criteria:

- Be formally angel-backed by a NACO member in good standing, and
- Have received a minimum equity financing of \$50,000 from a NACO member angel investor, within the past 24 months

If you DO meet the criteria, you will receive a confirmation email from BDO. One of the BDO team members will contact you in 1 - 2 business days to schedule a preliminary meeting to understand your business needs and review the bundle package. Following that meeting we will confirm the services that best suit your needs and begin the onboarding process.

If you DO NOT meet the criteria, you will receive a notification email from NACO.

WHAT IF I DON'T KNOW WHAT BUNDLE TO SELECT?

Each bundle addresses a specific business need. If you would like to address more than one need, select all the bundle packages that apply to you. Once your application is received and approved, a BDO professional will sit down with you to understand your business challenges and develop a custom package that addresses all your needs.
